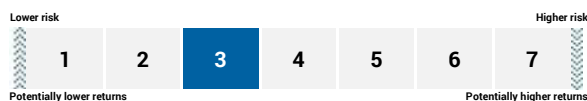
Description of this fund

Invests in New Zealand bonds, with the objective of outperforming the S&P/NZX A-Grade Corporate Bond Index over rolling three-year periods.

Total value of the fund: \$429,329,327

What are the risks of investing?

Risk indicator for the Smartshares NZ Bond ETF



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

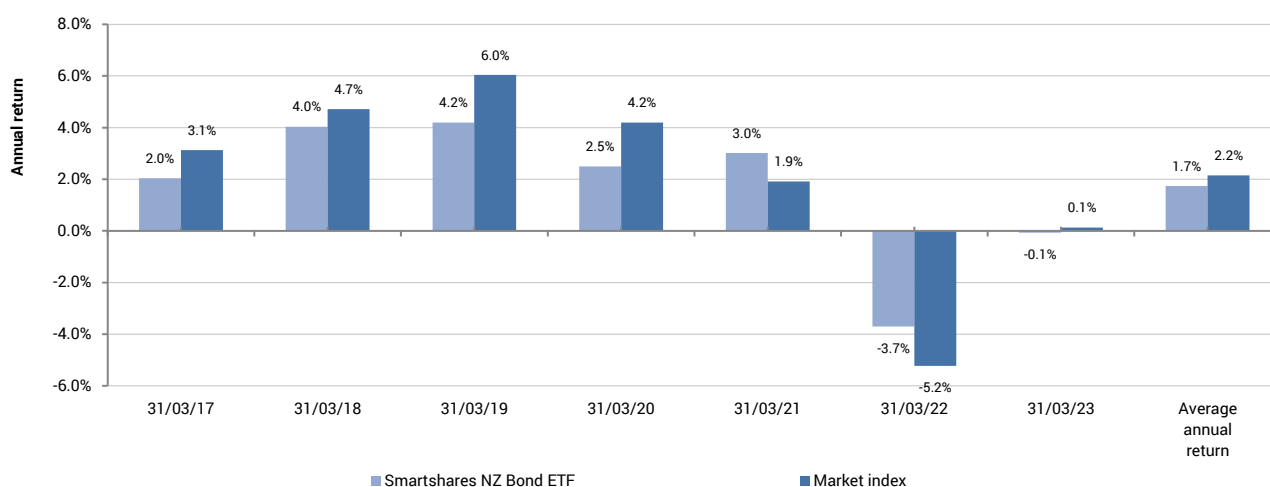
How has the fund performed?

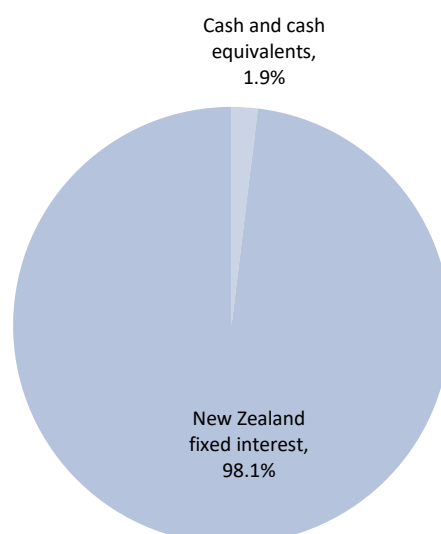
Example of how this applies to an investor

Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara received a return after fund charges were deducted but before tax of \$199 (that is 1.99% of their initial \$10,000). This gives Tara a total return after tax of \$144 for the year.
