This fund update was first made publicly available on 26 July 2024.

What is the purpose of this update?

This document tells you how the Smartshares NZ Cash ETF has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Invests in New Zealand cash, with the objective of outperforming the S&P/NZX Bank Bills 90-Day Total Return Index over rolling 1-year periods.

What are the risks of investing?

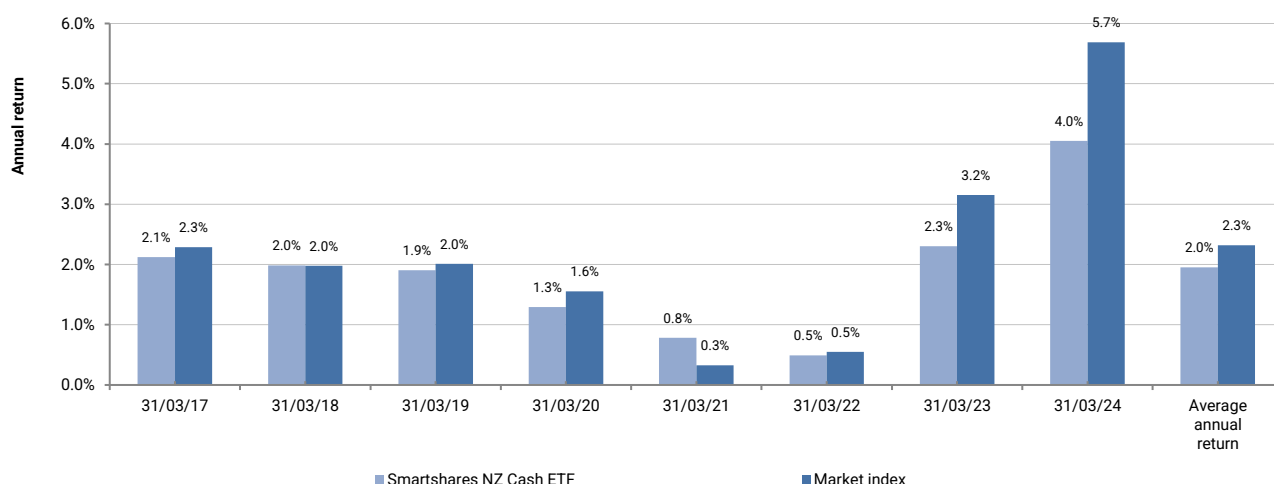
How has the fund performed?

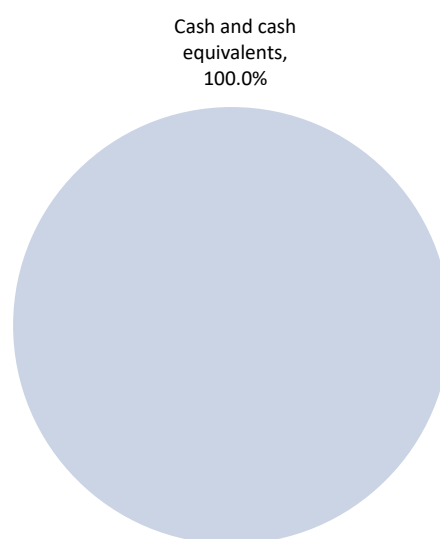
Example of how this applies to an investor

Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara received a return after fund charges were deducted but before tax of \$584 (that is 5.84% of Tara's initial \$10,000). This gives Tara a total return after tax of \$417 for the year.
