In accordance with General Instruction E of Form S-8, the contents of the Registrant's Registration Statement on Form S-8 (File No. 333-140701), filed with the Securities and Exchange Commission (the "Commission") on February 14, 2007, as supplemented, amended or superseded by the Registrant's Registration Statements on Form S-8 (File Nos. 333-149237, 333-159306, 333-165144, 333-172492, 333-180770, 333-187406, 333-194833, 333-203028, 333-210420, 333-216893, 333-223838 and 333-230391) filed with the Commission on February 14, 2008, May 18, 2009, March 2, 2010, February 28, 2011, April 17, 2012, March 21, 2013, March 26, 2014, March 26, 2015, March 28, 2016, March 23, 2017, March 22, 2018 and March 19, 2019 respectively, are incorporated herein by reference and the information required by Part II is omitted, except as supplemented by the information set forth below. References to "we", "our" or "us" below refer to Allot Ltd. and its consolidated subsidiaries.
