According to information provided to the company by Harel Insurance Investments & Financial Services Ltd (the "Holder"), the controlling shareholders in the Holder are Mr. Yair Hamburger ID 007048671, Mr. Gideon Hamburger ID 007048663, Mrs. Nurit Manor ID 051171312. The holding of the controlling shareholders in the Holder is mainly through G.Y.N Economic Consulting and Investment Management 2017 Limited Partnership (Partnership No. 550272587) (the "G.Y.N Partnership"). The Partnership is fully owned and controlled by the controlling shareholders, held by them as limited partners through wholly-owned private corporations, and as the general partner of the G.Y.N Partnership. The holdings appearing under provident funds in the company's shares include direct holdings by the provident funds in the security (150 par value), and holdings by the "Harel Amitim Menayot Israel" partnership (the "Partnership") totaling 4,049,035 par value. The partnerships are partnerships registered in the Partnerships Register, and all rights in them are held by institutional reporting group companies from Harel Group. The partnerships themselves are not provident fund management companies. According to the partnership agreement between the rights holders, the holding rate of the rights holders in the partnerships changes frequently, according to the mechanism set in the partnership agreement. The holding rate in the partnerships as of 20.10.2025: Harel Amitim Menayot Israel - profit participant 23.53%, provident funds 76.47%. It is clarified that the interested party's holdings as stated are as of 20.10.2025. For the avoidance of doubt, it is clarified that on 10.11.2025 the company executed a final redemption of government bonds (Series 1') in accordance with the repayment schedule.
