- **1.** Today, August 25, 2025, a tender was held to receive early commitments from classified investors, as defined in Regulation 1 of the Securities Regulations (Manner of Offering Securities to the Public), 2007 ("Classified Investors"), in connection with a possible public offering of the Company's bonds according to a shelf offering report, by way of expanding an existing bond series the Company's bonds (Series 15) (the "Tender" and the "Bonds", respectively).
