The company hereby announces that on October 17, 2025, a fire broke out at the burn facility of Hishlei Carmel Ltd. (the "facility" and "Hishlei Carmel", respectively) in Tirat Carmel, a consolidated company indirectly held by the company, operating in the group's parts sector. The fire was extinguished with the assistance of the Fire Authority teams with no casualties. The facility serves some of Hishlei Carmel's products in the quality control process at the final stages of the production process. The company notes that the main production lines of Hishlei Carmel were not damaged in the fire. In an initial assessment, the reactivation of the facility and its return to full operation is expected to take several months. The company has examined and assesses that there is a technical ability to meet supply requirements without significant impact on the group's operations, by using the company's facility in Bet Shemesh. At the same time, as mentioned above, the company is preparing for the rehabilitation and restoration of the facility at Hishlei Carmel. At this stage, the company continues to examine the implications of the fire at the facility. Hishlei Carmel has insurance policies, including loss of profits insurance, all in accordance with the terms of the policy. The company has notified the insurance company of the event. It should be clarified that the above initial assessment, including the expected return of the facility to full operation and the provision of a solution at the company's facility in Bet Shemesh, constitutes forward-looking information as defined in the Securities Law, 1968, the realization of which depends, among other things, on factors not under the company's control and which there is no certainty will materialize as the company has assessed.
