Settlement arrangement in a class action, against Bezeq International

1. Further to the immediate report of the company dated 12.11.2020 (reference number 2020-01-121866) and to the description in section 4.12.1(d) of the chapter 'Description of the Corporation's Business' in the company's periodic report for 2024, regarding a request for approval of a class action against the subsidiary Bezeq International Ltd. (hereinafter: "Bezeq International"), claiming that Bezeq International collects payments for the provision of 'antivirus service' and 'backup service' without them actually being provided, as allegedly it does not disclose to customers at the time of contract that they need to take proactive actions themselves to use, including installing special software, and that the charge starts at the time of signing the contract and not from the actual provision of service — a supplementary immediate report is hereby given that on 12.1.2026 the company received a notice from Bezeq International regarding the court's approval of a settlement arrangement between it and the plaintiffs, which includes compensation totaling NIS 6,250,000 to group members, and an amount of NIS 1,500,000 plus VAT as remuneration to the representative plaintiffs and legal fees to their counsel.
