Ltd. (the "**Issuer**"), a wholly-owned subsidiary of CICT, pursuant to its S\$7,000,000,000 Multicurrency Medium Term Note Programme ("**MTN Programme**") unconditionally and irrevocably guaranteed by HSBC Institutional Trust Services (Singapore) Limited, in its capacity as trustee of CICT.

The Manager wishes to announce that the Issuer has today (being the maturity date of the Notes) made payment for the redemption in full of all the outstanding Notes in an aggregate principal amount of S\$150.0 million at 100.0 per cent. of its principal amount.

The Manager also wishes to announce that following the full redemption of all the outstanding Notes on 2 August 2024, the Notes will be cancelled with effect from 2 August 2024 in accordance with the terms and conditions of the Notes and, following such cancellation, there will be no outstanding Notes.
