Class Action Lawsuit Against Subsidiaries

A notice is hereby given that on November 30, 2025, a lawsuit and a request for approval as a class action under the Class Actions Law, 2006 (together: "the lawsuit") was filed with the Tel Aviv-Jaffa District Court against Clal Insurance Company Ltd., Clal Pension and Provident Fund Ltd., Clal Credit Insurance Ltd., Kanaf – Clal Financial Management Ltd., and Calabit Systems Ltd., wholly owned subsidiaries of the company (together: "Clal Companies"), and against another company (together: "the defendants").

The lawsuit alleges that Clal Companies violated legal provisions and infringed upon their customers' privacy by utilizing the services of the additional defendant to establish a digital customer service system, thereby allowing the additional defendant access to highly sensitive personal information, without revealing this to customers and without receiving their informed consent.

The group the plaintiff seeks to represent consists of customers of the Clal group whose privacy was infringed due to actions and omissions by the Clal Companies, including cases where the additional defendant was exposed to personal and private data about them and/or collected and stored the data and/or transferred the data to a third party and/or abroad.

The main remedies sought in the lawsuit are compensation for non-monetary damages; to instruct the Clal Companies to cease the conduct at the heart of the request for approval and to ensure that the customers of the Clal group are informed and their informed consent obtained; to instruct the additional defendant to delete the information stored with it and/or any third party; to instruct the defendants to provide detailed accounts of the profits obtained as a result of their conduct and to order that the profits be transferred to the group members.

The plaintiff estimates the damage to each group member at 1,000 NIS, and thus estimates the total cumulative damage for group members to exceed 3 million NIS.

The Clal Companies are studying the lawsuit.
