**Note 1**

As reported to the company by the interested party, Menora Mivtachim Holdings Ltd (hereinafter: "Menora Holdings"), the company is a public corporation whose shares are traded on the Tel Aviv Stock Exchange. The principal shareholders of the company are Palms Establishment and Neyden Establishment (foreign corporations) holding together in trust about 62.72% (considering the dormant shares) of the company's shares for Ms. Tali Gripel and Ms. Niva Gurevich, respectively. The foreign corporations have granted Ms. Tali Gripel and Ms. Niva Gurevich powers of attorney to vote on behalf of each of the corporations (respectively) at the company's general meetings. Therefore, Ms. Tali Gripel and Ms. Niva Gurevich are considered the controlling shareholders.

The holdings shown for security 314013 under provident funds and companies managing provident funds are the holdings of a partnership whose beneficiaries are institutional reporting group companies from the Menora Mivtachim Group (totaling 538,161 shares). The partnership itself is not a provident fund management company. According to the partnership agreement between the beneficiaries of the partnership, the holding rate of the beneficiaries in the partnership changes regularly, according to the mechanism set out in the partnership agreement.

As of the reporting date, the holding percentages in the domestic equity basket are: 8.77% Amitim (participating in profits); 91.23% pension + provident.

The transaction price reflects the average trading price of seven transactions that took place between 20.11.2025 and 22.12.2025 at transaction prices ranging from 44,232.95 agorot to 46,594.92 agorot.
