**Nature of the event: *Filing of a motion for class action against the Company***

1. The Company hereby announces that it has been brought to its attention that on June 30, 2026, a claim was filed with the Central-Lod District Court, together with a motion to approve it as a class action, against the Company and against directors and officers in it. The subject of the claim is the allegation that the Company's reports allegedly included misleading details regarding the value of its holding in the shares of Hailo. The damage alleged in the motion to the members of the class is approximately NIS 9.4 million. It should be noted that as of the date of this report, the claim has not yet been duly served to the Company. The Company, with the assistance of its legal advisors, will study the claim once it is served to it and will submit its detailed response to the court in accordance with the provisions of the law. In light of the above, at this stage the Company is unable to assess the chances of the motion for approval being approved as a class action, and if it is approved – the chances of the claim being accepted and the scope of the damages that will actually be awarded, if any are awarded.
