Regarding Section F:

As detailed in section 1.20.5 of Part A of the 2024 periodic report, the company guarantees the repayment of senior debt loans used for the construction of systems by held corporations. These guarantees are released after the completion of the construction and the arrangement of long-term financing. As of June 30, 2025, these guarantees amounted to a total (principal) of approximately 1,001,137 thousand NIS. For the balance of dollar guarantees, see section 10.c in the consolidated financial statements for 2024. Regarding the amount specified in section G, as detailed in section 1.20.5 of Part A of the 2024 periodic report, some of the consolidated companies in the group, which are designated holding corporations, have arranged with banks financing frameworks for the provision of senior debt loans for the construction of systems, and they guarantee the repayment of these loans, which are spread over many facilities. The amounts in section K represent credit amounts received by a wholly owned subsidiary of the company, which are included in section H, and which were given to the company as a loan from the said consolidated company, under the same terms as its own loan.
