The company is honored to announce, with reference to Section 15.6(b) of Chapter A in the company's periodic report for 2024 as well as note 6c(7) to the company's consolidated financial statements for 2024, which were attached to the said periodic report (the "note"), regarding real estate at the corner of Rothschild - Yehuda Halevy and Bezalel Yafe Street in Tel Aviv, in which the company holds a 50% stake (through a wholly owned project company) and is advancing together with a third party who also holds 50% (the "project company" and the "third party", as defined in the note), including with respect to a right granted to that third party to require the project company to purchase from him the remainder of his rights in the real estate, against payment of consideration of 100 million NIS and additional amounts as agreed (the "option"), that the company and the third party have agreed to extend the period in which the third party may exercise the option, and that it shall be valid until no later than February 5, 2026. By this date, the third party will examine alternatives, which include, among others, exercising the option or selling his share to another external entity.
