The partnerships are partnerships registered with the Registrar of Partnerships, and all rights holders are companies of the Phoenix institutional reporting group. The partnerships themselves are not provident fund management companies. According to the partnership agreement among the rights holders in the partnerships, the holding percentage of the rights holders in the partnerships changes frequently as per the partnership agreement mechanism.
