Subject of the event: Notice of the exercise of the option by Phoenix Insurance Company Ltd. to purchase shares of EL AL Frequent Flyer Ltd.

Following Note 14 to the company's financial statements as part of the company's periodic report for 2024 (reference: 2025-01-016342), and following Note 6 to the company's Q2 2025 financial statements (reference: 2025-01-064667), the company hereby updates that on October 29, 2025, the company received notice from Phoenix Insurance Company Ltd. regarding the exercise of the option to purchase shares of its subsidiary - EL AL Frequent Flyer Ltd. ("the Subsidiary"), at a rate of 5.1% of the issued and paid-up share capital of the Subsidiary ("the Option"), subject to receipt of regulatory approvals, if and as received. After the exercise of the option, if exercised, the Phoenix Group will hold 25% of the issued and paid-up share capital of the Subsidiary. It should be noted that the proceeds to be received by the company, if any, from the exercise of the option, will not be material. The receipt of the regulatory approvals concerning the exercise of the option, as stated, is forward-looking information as defined in the Securities Law, 1968, and therefore the exercise of the option and the actual allocation of shares may not be realized or may be materially different, as it depends on third parties not under the company's control.
