Further to the company's report dated January 1, 2024 (reference number: 2024-01-000129), and further to Note 16.b.8 in the company's periodic report for 2024 as published on March 12, 2025 (reference number: 2025-01-016342), regarding a request for approval of a class action lawsuit that was filed against it in the Central District Court (the "certification request"), in the amount of NIS 96,600,000, which alleged that a notice sent by the company in December 2022 to members of the "Matmid Frequent Flyer Club" (the "Club") regarding a change to the Club's plan effective from September 1, 2023 — concerning the expiry limitation of points accumulated or to be accrued in the future due to flights purchased prior to the date of change — contained purported misrepresentations, whereby the change was allegedly presented as beneficial to Club members, while in fact it was argued that it worsened their situation. The company is honored to update that on November 24, 2025, a court ruling was made ordering the deletion of the certification request, due to difficulties raised by the request both on a factual and legal level, and after it was determined that managing the dispute as a class action suit is not the appropriate method for resolving the disagreement under the circumstances.
