Court judgment regarding withdrawal from a motion for approval of a class action lawsuit

Further to the company's report on 25 September 2024 (reference number: 2024-01-605605), and further to Note 16.B.10 to the company's annual report for 2024, as published on 12 March 2025 (reference number: 2025-01-016342), regarding a motion for approval of a class action lawsuit which was filed against it and against the subsidiary El Al Frequent Flyer Ltd., in the District Court in Tel Aviv ("the approval motion"), in the sum of 120,000,000 NIS, addressing three issues:

1. The applicants alleged that the company sometimes does not credit at all, and at times credits belatedly, club members with diamonds and points, where it is claimed that such members are entitled to accrue diamonds and points;
2. The applicants alleged that the company charges club members for choosing a SPACE seat and/or an upgraded seat, even though it is claimed these club members are entitled to a free SPACE seat;
3. The applicants alleged that the company offers a certain preferred seat for sale even after it has already been sold previously.

The company hereby updates that on 24 December 2025, a court judgment was issued approving the applicants' withdrawal from the approval motion, without an order for costs, determining that the approval motion presented significant difficulties, including regarding the assessment of the alleged damage as well as the scope of the alleged group members.
