The company hereby announces that, further to the immediate (amended) report of the company dated 6.1.2026 regarding the distribution of a cash dividend in the amount of 57 agorot per share (reference number: 2026-01-002525), and pursuant to Section 9.10.3 of the Company's shelf offering report published on 31.3.2024 (reference number: 2024-01-029338) (the "Shelf Offering Report"), the Company has made an adjustment to the exercise price of the Company's warrants (Series 3), as a result of the anticipated dividend distribution as stated above.
