

ELBIT IMAGING ANNOUNCES DISPUTE BETWEEN ITS CONTROLLING SHAREHOLDERS AND BANK HAPOALIM – UPDATE

Tel Aviv, Israel, April 7, 2013, Elbit Imaging Ltd. ("EI" or the "Company") (TASE, NASDAQ: EMITF) announced today, further to the Company's announcement dated February 28, 2013, that Europe Israel (MMS) Ltd. ("Europe Israel") has notified the Company of the cancellation of the temporary foreclosure proceedings. At the consent of the parties to the above proceedings, Bank Hapoalim B.M. (the "Bank"), Mr. Mordechay Zisser and Europe Israel, the Tel Aviv District Court (the "Court") has appointed Adv. Giroa Erdinast as an Observer Trustee on behalf of the Court with regards to the shares of the Company held by Europe Israel and securing Europe Israel's obligations under the loan agreement with the Bank, for the monitoring of the negotiations regarding a restructuring of the outstanding indebtedness of the Company.

In certain circumstances and depending on market conditions, we operate and manage commercial and entertainment centers prior to their sale; (ii) <u>U.S. Real Property</u> - Investment in commercial real property in the United States; (iii) <u>Hotels</u> - Hotel operation and management; (iv) <u>Medical Industries</u> - (a) research and development, production and marketing of magnetic resonance imaging guided focused ultrasound treatment equipment and (b) development of stem cell population expansion technologies and stem cell therapy products for transplantation and regenerative medicine; (v) <u>Residential Projects</u> - Initiation, construction and sale of residential projects and other mixed-use real property projects, predominately residential, located primarily in India; (vi) <u>Fashion Apparel</u> - Distribution and marketing of fashion apparel and accessories in Israel; and (vii) <u>Other Activity</u> - venture capital investments.
