

## ELBIT IMAGING LTD. ANNOUNCES RECEIPT OF NOTICE CONCERNING OPERATION OF MANGO RETAIL STORES

**Tel Aviv, Israel, September 29, 2014, Elbit Imaging Ltd.** ("EI" or "Company") (NASDAQ GSM: EMITF) announced today that its subsidiary Elbit Fashion Ltd. ("**Elbit Fashion**") received from PUNTO FA, S.L ("**Punto**") written notice of its intention not to extend the term of the franchise rights of Elbit Fashion for operation of the "Mango" retail stores in Israel, as granted under the agreement entered between Elbit Fashion and Punto on May 3, 2005 (the "**Agreement**") and to terminate the Agreement such that the vast majority of Elbit Fashion's "Mango" stores are scheduled to be closed on May 2015 while the remaining stores are scheduled to be closed during 2016 and 2017.

The Company and Elbit Fashion are currently reviewing and evaluating the aforementioned notice and the implications thereof and intend to vigorously protect and uphold their rights under the Agreement and any applicable law.
