

ELBIT IMAGING LTD. ANNOUNCES ADDITIONAL BUYBACK OF NOTES SERIES I

Tel Aviv, Israel, October 18, 2018, Elbit Imaging Ltd. ("EI" or the "Company") (TASE, NASDAQ: EMITF) announced today, further to its press releases dated July 18, 2018 and October 11, 2018, regarding a new Buy-Back plan for its (Series I) notes (the "**Notes**" and the "**Current Buy-Back Plan**", respectively), that it completed repurchases of additional 5,203,984 par value Notes.

Below is a table containing a summary of data regarding the repurchase of Notes under the Current Buy-Back Plan:

Since the issuance of the Notes (in February 2014) and until the date of this press release, the Company has published two (2) buy-back plans for the repurchase of up to NIS 120 million of Notes. As of the date of this press release, the Company has purchased par value NIS 67.7 million Notes for a total cash consideration of NIS 81.7 million.
