



Elbit Systems Announces the Results of its Extraordinary General Meeting of Shareholders Held on March 8, 2016

Haifa, Israel, March 9, 2016 - Elbit Systems Ltd. (NASDAQ and TASE: ESLT) (the "Company") announced today that at its Extraordinary General Meeting of Shareholders (the "Meeting") held on March 8, 2016 at the Company's offices in Haifa, the proposed resolutions described in the Proxy Statement to the Shareholders dated February 2, 2016 (the "Proxy") and set forth hereunder, were approved by the required majority:

1. that the terms of office and employment of Mr. Bezhael (Butzi) Machlis, the Company's President and CEO, described in the Proxy are approved, effective from April 1, 2016.
2. that Dr. Yehoshua Gleitman is elected as an External Director of the Company for an additional three-year term commencing on the close of the Meeting and ending on March 7, 2019, inclusive.
