(NASDAQ: ESLT and TASE: ESLT) (“Elbit Systems” or the “Company”) announced today that it was awarded a \$135 million contract to establish an artillery ammunition factory for an international customer. The contract will be performed out over a period of two years.

Elbit Systems builds and operates ammunition factories and production lines in multiple sites. The Company's experience covers the entire product cycle, from design to production as well as maintenance and after sales support.
