On November 26, 2025, the Audit Committee and the Board of Directors of the Company approved the purchase of various liability insurance policies, as part of a group purchase by the companies in the ELCO LTD group ("Elco"), including the approval of the Company's portion in the allocation of premium payments among the companies in the Elco group, in accordance with the provisions of Regulation 1(4) of the Companies Regulations (Relief in Transactions with Interested Parties), 2000. All is based on an analysis carried out by the group's insurance consultant, based, among other things, on the nature of the risk, the insurance market's outlook on such risk, the activity cycles and past data of the companies.

Both the Audit Committee and the Board of Directors found that the terms of the insurance policies offered to the Company do not differ materially from the terms offered to Elco and the other companies in the group, considering each company's relative share, which was determined, as mentioned, according to the recommendation of an independent and external consultant.

In addition, based on the letters from the insurance consultant - the Company's share in the allocation of premium payments among the Elco group companies is fair and reasonable, and even reduces the premium costs compared to a situation where the Company would purchase insurance separately from the group. Accordingly, the transactions are in the Company's best interest.
