("Offeror") made a voluntary conditional cash offer for all the issued ordinary shares ("GDL Shares") in the capital of GDL, including all the GDL Shares already owned, controlled or agreed to be acquired by parties acting or deemed to be acting in concert with the Offeror.

On 17 March 2023, JK Global Assets Pte. Ltd. validly tendered all its 404,381,666 Shares in acceptance of the Offer. Please refer to Substantial Shareholder's A information above. Mr Koh Wee Meng is the sole shareholder and director of JK Global Assets Pte. Ltd. and was deemed interested in the 404,381,666 GDL Shares held by JK Global Assets Pte. Ltd..

As Mr Koh Wee Meng is also the sole shareholder of the Offeror, Mr Koh Wee Meng continues to be deemed interested in 404,381,666 of GDL Shares held by the Offeror. Accordingly, there is no change in the total percentage level of interests of Mr Koh Wee Meng.
