Further to the immediate report published by the company on December 7, 2025 (reference number: 2025-01-097094), the company is pleased to announce that on December 19, 2025, the transaction for the sale of rights in a housing cluster in Charleston, South Carolina, USA, by the third fund for investments in housing clusters, was completed. The consolidated company has received the full consideration thereof. From the date of its acquisition until realization, the NOI (Net Operating Income) of the asset increased by approximately 53%. The final annual yield rate (IRR) at the asset level is approximately 19.8% and the equity multiple is approximately 2.43.
