For the purpose of calculating the holding percentage on a fully diluted basis, the exercise of 20,118,381 long-term warrants exercisable, via a Cashless mechanism (net exercise), into 3,329,355 exercise shares was taken into account. Since the exercise of the warrants is conditional upon meeting a target price set for this purpose depending on the series of warrants, the number of exercise shares was calculated according to the higher of (1) the target price set for the series; or (2) the closing price of the share as of August 18, 2025. Below is a breakdown of the share price used for calculating the number of exercise shares: (1) 15,366,333 warrants based on a share price of NIS 20.08, which is the target price for exercising these warrants; (2) 1,240,086 warrants based on a share price of NIS 25.98, which is the target price for exercising these warrants based on a share price of NIS 29.44, which is the target price for exercising these warrants; (4) 2,219,946 warrants based on a share price of NIS 22.92, which is the target price for exercising these warrants.
