LIBRA GROUP LIMITED SECURES NEW CONTRACTS

The Board of Directors (the “**Board**”) of Libra Group Limited (the “**Company**”, and together with its subsidiaries, the “**Group**”) is pleased to announce the following Award of contracts to Cyber Builders Pte Ltd, a wholly-owned subsidiary of the Group:

- (1) a contract awarded by Jacksonville Pte Ltd for the proposed new erection of one block of 5-storey residential buildings at 111 Koon Seng Road (Geylang Planning Area) (the “**Koon Seng Contract**”). The works under the Koon Seng Contract are scheduled to be completed in 2018.
- (2) A sub-contract awarded by China Railway No.5 Engineering Group Co., Ltd, Singapore Branch for the supply, installation, construction, completion and maintenance of architectural works to Lentor Station (the “**Lentor Station Contract**”). The works under the Lentor Station Contract are scheduled to be completed in 2020.
- (3) A sub-contract awarded by Daewoo Engineering & Construction Co., Ltd for the supply, installation, construction, completion and maintenance of architectural works to Stevens Station (the “**Stevens Station Contract**”). The works under the Stevens Station Contract are scheduled to be completed in 2020.

The aggregate value under the abovementioned contracts is approximately S\$42 million. None of the Directors or substantial shareholders of the Company has any interest, whether direct or indirect, in the above contracts, other than through their shareholdings in the Company.

The abovementioned contracts have been entered in the Group’s ordinary course of business and are expected to have a positive impact on the consolidated earnings per share and/or net tangible assets per share for the Group for the financial year ending 31 December 2017.
