(i) Based on the results of the Rights Cum Warrants Issue as announced on 31 July 2024 and 1 August 2024, the Company had allotted and issued 112,000,000 Rights Shares and 224,000,000 Warrants to Entitled Shareholders. In particular, 23,500,000 Rights Shares and 47,000,000 Warrants (each Warrant carrying the right to subscribe for one (1) new ordinary share) were issued to Tang Hee Sung pursuant to the Rights Cum Warrants Issue.
