Further to the immediate report dated May 8, 2018 (reference no. 2018-01-046180) and to the provisions of Note 25 Z.1 to the Bank's financial statements for 2025 regarding a class action concerning the collection of fees from customers who claimed that they were entitled to be covered by the definition of "small business," the Bank updates that on April 23, 2026, the Tel Aviv-Jaffa District Court approved a settlement, under which it was determined, inter alia, that the Bank will pay amounts that are not material, to the class, to the applicant and to his counsel (the total amount is provisioned in the Bank's books). The Bank also undertook to classify customers' accounts according to their financial statements, all in accordance with the conditions set out in the settlement.
