The BOX enables immediate injection of 5kW power with long duration run-time and is highly resilient to extreme environmental conditions. In addition, the BOX is compact in size to fit small outdoor installations, it can be serviced by one simple annual maintenance and allows easy plug-and-play installation. The BOX has zero CO₂ emissions, is free of noise or vibrations and has been designed to connect with standard telecom Energy Management System protocols.
