Harel Insurance Investments & Financial Services Ltd. (the "Company") is honored to report as follows:

As detailed in Note 12A(41) to the Company's financial statements as of June 30, 2025, published on August 28, 2025 (Reference: 2025-01-064516), and further to the immediate report dated December 23, 2024 (Reference: 2024-01-626448), in December 2024, a claim and a request for its approval as a class action were filed with the Central District Court (the "Court") against the subsidiary, HAREL INSURANCE COMPANY LTD. ("HAREL INSURANCE COMPANY LTD."), alleging that HAREL INSURANCE COMPANY LTD. acts, allegedly, contrary to the law and its obligations to its policyholders, by allegedly charging, in policies denominated in US dollars, insurance premiums calculated according to a dollar exchange rate higher than the representative rate to which it committed.

On September 15, 2025, a request was filed with the Court for the applicant to withdraw from the approval request, in which the Court is requested to approve the withdrawal and order the dismissal of her personal claim.

As part of the withdrawal request, HAREL INSURANCE COMPANY LTD. agreed to transfer to the Class Action Fund the amounts collected in excess from the group members in an amount that is not material. In addition, HAREL INSURANCE COMPANY LTD. agreed to pay the applicant and her attorney a reward and legal fees in amounts that are not material.

The withdrawal request is subject to the Court's approval.
