Harel Insurance Investments & Financial Services Ltd. hereby announces that a claim and a request for its approval as a class action have been filed with the Central District Court against its subsidiary, HAREL INSURANCE COMPANY LTD. ("Harel Insurance"). The subject of the claim is the allegation that, upon automatic renewal of a home structure insurance policy, Harel Insurance increases the insurance premiums charged to its policyholders by canceling discounts that the policyholders received in previous insurance years, allegedly without obtaining the policyholders' prior consent and contrary to law.

The group that the plaintiffs seek to represent includes all customers of Harel Insurance, for whom Harel Insurance renewed the home insurance policy with a deterioration of terms due to the cancellation of discounts that the customer received in the previous insurance year or the first insurance year, including discounts called "commission discount", "first month discount", "first two months discount" or any other name.

The plaintiffs do not quantify the total alleged damage for all members of the group they seek to represent, but estimate that it exceeds the sum of 3 million NIS.
