In its decision dated August 24, 2025, the District Court of Tel Aviv rejected motions for class action certifications that were submitted in April 2020 against the subsidiary, Harel Insurance Company Ltd., against Shirbit Insurance Company Ltd., and against additional insurance companies (collectively: the "Defendants"), on the grounds that the Defendants do not return to their insureds in compulsory car, comprehensive, and third party insurances, insurance premiums which were allegedly overpaid by them, following a claimed significant reduction in the risk level to which the Defendants have been exposed since March 2020, due to a reduction in economic activity as a result of the COVID-19 outbreak and a subsequent decrease in vehicle mileage.

On November 11, 2025, the applicants of these certification requests filed an appeal against the verdict to the Supreme Court.
