Harel Insurance Investments & Financial Services Ltd. (the "Company") is pleased to report as follows:

As detailed in Note 12a(32) to the Company's financial statements as of September 30, 2025, published on November 25, 2025 (Reference: 2025-01-091342), and following the immediate report dated September 20, 2023 (Reference: 2023-01-088240):

In September 2023, a claim and a request to approve it as a class action were filed with the Regional Labor Court in Tel Aviv (the "Court") against the subsidiary, HAREL INSURANCE COMPANY LTD., and against Clalit Health Services (together: the "defendants"), on the grounds that the defendants tend to charge a parent for long-term care insurance for their child who reached the age of 19, supposedly, without explicit approval or consent prior to the start of the payment, and without notice, warning and/or information as required by law.

On December 15, 2025, the Court was submitted an application for the petitioners to withdraw from the approval request, within which the Court is requested to approve the withdrawal and order the dismissal of the individual claim of the petitioners.

The withdrawal request is subject to Court approval.
