On December 17, 2025, the plaintiff filed an appeal against the judgment to the Supreme Court.

As detailed in note 12b(6) to the Company's financial statements as of September 30, 2025, which were published on November 25, 2025 (Reference: 2025-01-091342), and in immediate reports dated October 23, 2025 (Reference: 2025-01-079247), June 20, 2018 (Reference: 2018-01-053820), January 25, 2022 (Reference: 2022-01-010939), May 24, 2022 (Reference: 2022-01-051234) and January 8, 2024 (Reference: 2024-01-003837);

In its ruling dated October 23, 2025, the Jerusalem District Court adopted the conclusions from its decision to approve from January 2022, regarding a request to approve a class action against the subsidiary, Harel Insurance Company Ltd. ("Harel Insurance"), and against another insurance company (the "defendants"). The matter concerns a claim that the defendants refuse to recognize a surgery, which there is a medical necessity to perform, as an insured event under their health insurance policies, claiming it is a preventive surgery – regarding policies that Harel Insurance marketed prior to 2011.

Regarding policies that Harel Insurance marketed starting from 2011, which had an annex/extension including preventive surgery, the ruling determined that they do not cover preventive surgery for those who did not purchase the annex/extension that includes preventive surgery.
