Conclusion of Class Action - Harel Insurance

Harel Insurance Investments and Financial Services Ltd. ("the Company") is pleased to report as follows: As detailed in Note 12a(32) to the Company's financial statements as at September 30, 2025, which were published on November 25, 2025 (Reference: 2025-01-091342), and further to the immediate reports dated December 15, 2025 (Reference: 2025-01-099807) and September 20, 2023 (Reference: 2023-01-088240);

On December 15, 2025, a petition for the withdrawal of the petitioners from the claim and a petition for its approval as a class action ("the Approval Petition") was submitted to the Regional Labor Court in Tel Aviv ("the Court"), which had been filed in September 2023 against the Company's subsidiary, HAREL INSURANCE COMPANY LTD. and Clalit Health Services (together: "the Defendants"), alleging that the Defendants tend to collect monetary payment from a parent for nursing insurance regarding their child who reached the age of 19, supposedly without explicit approval or consent prior to the start of the charge, and without notice, warning and/or making the parent aware as required by law.

On December 21, 2025, the Court approved the withdrawal of the petitioners from the Approval Petition and ordered the deletion of the Approval Petition and the dismissal of the personal claims of the petitioners.

Thus, the lawsuit has concluded.
