Harel Insurance Investments & Financial Services Ltd ("the Company") is honored to report as follows:

As detailed in Note 12a(41) to the Company's financial statements as of September 30, 2025, which were published on November 25, 2025 (Reference: 2025-01-091342), and further to immediate reports dated December 23, 2024 (Reference: 2024-01-626448) and September 15, 2025 (Reference: 2025-01-069518), in September 2025, the claimant submitted a request for withdrawal from the claim and the request for its approval as a class action ("the Approval Request"), which had originally been submitted in December 2024 against the subsidiary, Harel Insurance Company Ltd. ("Harel Insurance"), claiming that Harel Insurance allegedly acts contrary to the law and its commitments to policyholders, by allegedly collecting insurance premiums in dollar-denominated policies based on a dollar exchange rate higher than the representative rate to which it was obligated.

On January 4, 2026, the court approved the claimant’s withdrawal from the Approval Request and ordered the dismissal of the Approval Request and rejection of the claimant's individual claim.

Thus, the action has ended.
