Further to what is detailed in Note 12A(18) to the company's financial statements as of June 30, 2025, which were attached to the company's interim report published on August 21, 2025 (Reference No.: 2025-01-062290) (this information is incorporated by reference), regarding a claim and a request for its approval as a class action, filed against the company and against 9 other insurance companies (the "request" and the "respondents", respectively), concerning the fact that due to the "Iron Swords" war, a sharp decrease in risk for insurance companies is expected, which was not taken into account when determining the premium at the time of purchasing the insurance. Therefore, according to the plaintiffs, a partial or full refund of the premium should have been made in policies where, according to them, the risk components decreased significantly. The company announces that on August 27, 2025, the court approved the withdrawal request by agreement from the request with respect to the company only, without any costs being awarded.
