Further to the details in Note 12a(23) to the company's financial statements as of June 30, 2025, attached to the company's interim report published on August 21, 2025 (Reference No.: 2025-01-062290) (this information is incorporated by reference), regarding a claim and a request for its approval as a class action, filed with the Tel Aviv-Jaffa District Court against the company (the "respondent"), alleging that due to disruptions in the operation of devices supported by location services (GPS) that occurred in Israel as a result of the 'Iron Swords' war, the respondent allegedly charged incorrect amounts from its insured customers with car insurance for young drivers (the "request"), the company hereby announces that on September 11, 2025, the court approved the agreed withdrawal request, without awarding costs, after the applicant and his attorney acknowledged that the respondent does not act in the manner alleged in the request, that the charge in the applicant's case was made in accordance with the law and the agreement between the parties, and that under these circumstances there is no basis for the request and no chance it would be decided in favor of the group.
