Immediate Report

1. Following the disclosure in Note 12A1 to the financial statements for the second quarter of 2025, published on August 21, 2025, reference number 2025-01-062290 (this information is incorporated by reference), regarding a class action lawsuit that has been ongoing against the company since 2011. The main claim is that the company renewed, between 2005 and 2011, the vehicle-property insurance of some of its customers without their approval, unlawfully, and the request for certification as a class action set the total claim at 200 million NIS. The company hereby announces that on October 21, 2025, the Central District Court (hereinafter: "the Court") accepted the claim, among other reasons, because in its opinion, the guidelines of the Capital Market, Insurance and Savings Authority for the insurance sector, which allowed automatic renewal as mentioned above and according to which the company acted, were illegal, and the company should have ignored them. The Court ruled that the company must refund the group members the premiums they paid (plus interest and linkage differentials according to Section 28(c) of the Insurance Contract Law, 1981), even though during this period they received full insurance coverage from the company, were aware of it, and even used it according to their needs. Nevertheless, and as stated above, for the purpose of determining the refund amount to the group members, the Court appointed an expert on its behalf (as supervisor under Section 20(b)(1) of the Class Actions Law, 2006) to determine the final scope of the group and the average premium cost per insured in the relevant years. The Court also set the principles for calculating compensation to the plaintiffs and the plaintiffs' attorneys' fees in the case, as well as additional customary instructions for such a judgment. The company is studying the judgment and will appeal it in light of the many errors it believes were made.
