Details

The company hereby announces that on November 11, 2025, it was served (the "respondent") with a lawsuit and a request for its approval as a class action, submitted against the company to the Central District Court, on two separate claims:

A. That the respondent allegedly offers its clients to renew auto property insurance without reflecting to them how much they paid in the previous year and/or without reflecting a price increase, to the extent there is one;

B. That when selling or renewing compulsory auto insurance policies, the respondent allegedly refuses to grant discounts on compulsory insurance, citing the misleading claim that it is unable to lower the price (the "request").

The causes of action, according to the request, are the violation of the provisions of the Supervision of Financial Services (Insurance) Law, 1981, and various circulars of the Supervisor, violation of the Torts Ordinance (negligence tort and violation of statutory duty), breach of the duty of good faith in contract law, and unjust enrichment.

The group members which the plaintiffs wish to represent are:

- A. Anyone who has renewed and/or will renew their auto insurance policy with the respondent up to the date of a final judgment in the lawsuit, and was not informed by the respondent of the previous year's insurance price and/or was not told that he will pay a higher price than he paid in the previous year.
- B. Anyone who purchased and/or will purchase a compulsory vehicle insurance policy from the respondent, including renewals, and was misinformed that it is not possible and/or prohibited for the respondent to reduce the price of compulsory insurance until the date of a final judgment in the lawsuit.

The individual damage estimated by the plaintiffs against the respondent stands at a total of 1,027.5 NIS, which includes economic and non-economic damages. The total damage claimed for all group members against the respondent is, according to the plaintiffs' estimate, over 2.5 million NIS, since the plaintiffs, so they claim, cannot assess the final scope of the group.

The remedies sought in the request are to order compensation for the customers, to issue various mandatory injunctions, and to award fees and compensation to the plaintiffs and their attorneys. The respondent is examining the claims raised in the request.
