In continuation to the details specified in Note 12A21 to the financial statements for the third quarter of 2025, published as part of the quarterly report on November 25, 2025, reference number 2025-01-091526 (this information is included by reference) regarding a claim and a request for its approval as a class action, which was filed against the company in the Tel Aviv-Jaffa District Court (hereinafter: "the Court"), on the allegation that the respondent supposedly charges its vehicle insurance clients a separate deductible for each damage point, even if they supposedly resulted from a single insurance event, contrary to the law that allows collecting only one deductible per insurance event (hereinafter: "the request"), the company hereby announces that on December 11, 2025, the Tel Aviv-Jaffa District Court approved a joint application by the parties to withdraw the request, which included the payment of compensation, reimbursement of expenses and legal fees—to an extent immaterial to the company—clarification of the rules for charging deductible to insured parties, including at decision junctions, and a refresh of procedures.
