Supplementary report to the report filed on February 10, 2013.

Primary details added/completed:

Further to the Company's immediate report of January 2, 2012, and the immediate supplementary report of December 23, 2012, December 31, 2012, and February 7, 2013, an additional supplementary report is hereby provided that on April 10, 2013, the Company received a notice from its subsidiary, Pelephone Communications Ltd. ("**Pelephone**") that it had received an appeal filed with the Supreme Court on the District Court's decision to dismiss a claim and motion to certify it as a class action for NIS 380 million, which was filed against Pelephone on grounds that Pelephone misled a portion of its business customers and updated a portion of its rates contrary to the law.

The above information constitutes a translation of the Immediate Report published by the Company. The Hebrew version was submitted by the Company to the relevant authorities pursuant to Israeli law, and represents the binding version and the only one having legal effect. This translation was prepared for convenience purposes only.
