- 1. The remuneration paid to Mr. Bernstein, who serves as the Chairman of the Board, is identical to that paid to all directors of the company. The remuneration does not exceed the maximum amount allowed to be paid to external directors under the Remuneration Regulations, and it does not exceed the lowest remuneration paid to any director in the company.
- 2. To the best of the directors' knowledge, generally, the amounts specified in the Remuneration Regulations serve as an accepted benchmark for determining directors' remuneration in public companies in Israel, and considering that the proposed remuneration complies with the Remuneration Regulations and the Easement Regulations, the Board believes the remuneration is reasonable under the circumstances.
