Further to the immediate report from July 29, 2020 (reference: 2020-01-080664) and further to what is stated in Note 12(c)(4) to the company's financial statements as of September 30, 2025, which was published on November 30, 2025 (reference: 2025-01-094062) regarding a lawsuit and a request for its approval as a class action, which was filed with the Central District Court against Menora Mivtachim Insurance Ltd, a subsidiary of the company (hereinafter: "the claim", "the approval request", and "the defendant") and which concerns the allegation that, at the time of payment of insurance benefits, the defendant allegedly violates the terms of the policy and indemnifies the insured in the nominal amount stated in the policy without linking the stated amount to the consumer price index, and in particular the index relevant at the time the insurance contract was signed, the company hereby announces as follows:

On December 30, 2025, the court denied the approval request and ruled, among other things, that it accepts the defendant's proposal to transfer a non-material sum to the class action fund, due to the rounding down of insurance benefit payments, in any case where the payment is a total sum of 49 agorot (ag') or less. In addition, it was determined that despite the denial of the approval request and defects in the applicant's conduct, in light of the benefit yielded by the approval request as detailed above, the defendant will pay fees and compensation in a non-material sum. This brings the claim to an end subject to the right of appeal.
