Further to the company's reports dated January 27, 2025 and April 28, 2025 (reference numbers: 2025-01-007119, 2025-01-030005), the company hereby announces that on January 5, 2026, an agreement was signed between the subsidiary, Menora Fund Management ("the Investor"), and Yesodot A Financial Escort Ltd. ("Yesodot") for the exercise of 50.1% of Yesodot's shares in exchange for part of the credit line provided by the Investor in the amount of 150 million NIS, subject to the precedent conditions specified in the agreement.

At the time of conversion, the Investor will purchase an additional 10% under terms set forth in the agreement so that after the conversion of the credit line, the Investor will hold 60.1%.

It should be noted that the engagement agreement signed on January 27, 2025 stipulated that there are mutual warrants which, if exercised, the Investor will hold 100% of Yesodot’s shares, all according to the timelines set in the agreement.
