1	Mr. Eli Levy is a director of the company, co-CEO, and a controlling shareholder of the company. Mr. Eli Levy is the son of Mr. Yosef Levy. Mr. Eli Levy is a party to a shareholders' agreement, for voting and cooperation between Mr. Binyamin Meirov, Mr. Yosef Meirov, B.Y.M. More Investments Ltd, and Mr. Yosef Levy and Mr. Eli Levy. For details, see section 8.4.1 of the company prospectus dated January 31, 2024. 5,297,680 of the shares are held through Aldot Ltd, registration number 515616761, a private company wholly owned by Mr. Eli Levy, and 24,800 shares are held by Mr. Eli Levy directly. It is noted that some of the shares are held through a self-managed pension fund (IRA). The purpose of this report is the engagement of Aldot Ltd in a financial equity swap transaction with a banking corporation, pursuant to which the bank acquired exposure to the returns on 750,000 shares of the company (by way of cash settlements only) in exchange for interest payment, as determined in the transaction. The final settlement date will be December 30, 2026, but Aldot Ltd has the right to terminate the transaction earlier, as of the elapse of three months from the date of engagement. The transaction price field above indicates the reference price set in the swap.
