On May 27, 2026, Mr. Eldad Tzinman ("Mr. Tzinman"), CEO of Mor Gemel and Pension Ltd. ("Mor Gemel and Pension"), a subsidiary of the Company, purchased 36,000 ordinary shares of Mor Gemel and Pension (security number: 1184381) in a single transaction on the stock exchange, at a price of 1,650 agorot. Before the purchase of the shares, Mr. Tzinman held 285,910 shares of Mor Gemel and Pension. Following the above-mentioned purchase of shares, Mr. Tzinman holds 321,910 shares of Mor Gemel and Pension, constituting approximately 0.25% of the equity and voting rights of Mor Gemel and Pension. In addition, Mr. Tzinman has 892,221 warrants (not listed) convertible into shares of Mor Gemel and Pension held by a trustee, so that his holdings in the equity and voting rights of Mor Gemel and Pension Ltd. on a fully diluted basis amount to approximately 0.88%.
