PARTNER COMMUNICATIONS ANNOUNCES DIVIDEND DISTRIBUTION OF NIS 1.89 PER SHARE FOR THE FOURTH QUARTER OF 2009

Rosh Ha'ayin, Israel, March 16, 2010 – Partner Communications Company Ltd. ("Partner" or "the Company") (NASDAQ and TASE: PTNR), a leading Israeli communications operator, announced today that its Board of Directors approved the distribution of a dividend for the fourth quarter of 2009 of NIS 1.89 (approximately US 50 cents) per share or ADS (in a total of approximately NIS 293 million or US\$ 79 million) to shareholders and ADS holders of record on April 7, 2010. The dividend is expected to be paid on April 22, 2010.

The Board of Directors has approved a dividend policy, targeting at least 80% payout ratio of the Company's annual net income for the year 2010.

The Company provides mobile communications services to over 3 million subscribers in Israel (as of December 31, 2009). Partner's ADSs are quoted on the NASDAQ Global Select Market™ and its shares are traded on the Tel Aviv Stock Exchange (NASDAQ and TASE: PTNR).

Partner is an approximately 45%-owned subsidiary of Scailex Corporation Ltd. ("Scailex"). Scailex's shares are traded on the Tel Aviv Stock Exchange under the symbol SCIX and are quoted on "Pink Quote" under the symbol SCIXF.PK. Scailex currently operates in three major domains of activity: 1) the sole import, distribution and maintenance of Samsung mobile handset and accessories products primarily to the three major cellular operators in Israel; 2) distribution and sale of various manufacturers' mobile handsets, accessories and provision of maintenance services, through a chain of retail stores and booths ("Dynamic"), to end customers of Cellcom (as part of the acquisition of the controlling stake in Partner, Scailex announced to Cellcom the termination of the distribution agreement through Dynamic, effective July 1, 2010 and On Jan 17, 2010 Scailex announced the sale of Dymanic's activity to Cellcom) and; (3) management of its financial assets.
